## Acknowledgement of 225 ILCS 320:

### Pursuant to 225 ILCS 320/3:

- All planning and designing of plumbing systems and all plumbing shall be performed only by an Illinois licensed plumber or an Illinois licensed plumber apprentice.
- An Illinois licensed plumber apprentice shall do planning and designing of plumbing systems and perform plumbing only under the direct supervision of the sponsor or sponsor's agent who is an Illinois licensed plumber.
- A plumber apprentice must possess a State license as a plumber apprentice.

### Pursuant to 225 ILCS 320/13.1:

- All employees of a registered plumbing contractor who engage in plumbing work shall be licensed plumbers or licensed apprentice plumbers.

### Pursuant to 225 ILCS 320/20:

- It is unlawful for an Illinois licensed plumber or plumber contractor to engage in "selling," loaning, or in any means transferring his or her license to another person(s), including the securing of plumbing permits for another to perform plumbing work.
